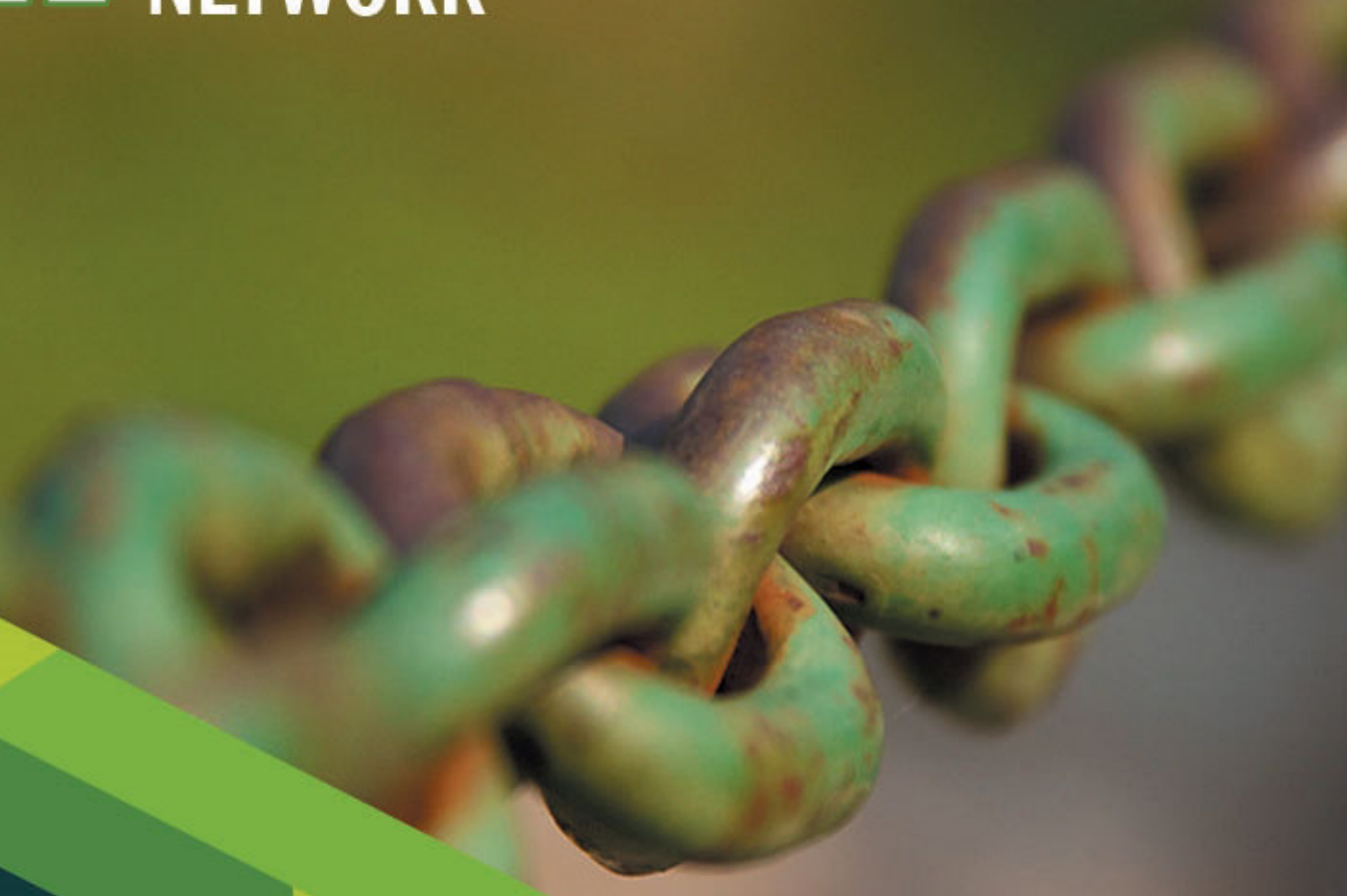

# Executive Green Supply Chain Awards.

Leading supply chain companies increasingly enforce sustainable business practices. And Supply & Demand Chain Executive wants to recognize your efforts in our annual “Executive Green Supply Chain Awards”.

**Executive Green Supply Chain Awards**, recognizing companies that are making sustainability a core part of their **supply chain strategies**.

## Background / Overview

Over recent years there has been a strong move towards companies “being green” and focusing on environmental sustainability. In an effort to recognize and reward those companies that show excellence in “going green”, The Professionals Network launched the Executive Green Supply Chain Awards programme in 2016.

The aim of the **Executive Green Supply Chain Awards** is to recognize and reward companies that are making genuine efforts to minimize the environmental impact of their supply chain processes and actively seek ways to improve



Identifying goals to reduce their company's impact on the environment;



Developing an action plan detailing how each of these goals will be achieved; and



Reporting progress towards achieving these goals.

The Executive Green Supply Chain Awards is the **ONLY** award in the Supply Chain arena devoted exclusively to greening the supply chain.

## Eligibility

Business enterprises, associations, private institutions, government bodies and non-governmental organizations (NGOs) are all eligible to submit entries to the Executive Green Supply Chain Awards.

Participants may submit as many individual entries as they wish.

## Scope

The Awards accepts entries covering all aspects of the supply chain. Details on the focus of each category are provided under the section “Categories”.

## Recognition

The Executive Green Supply Chain Awards will be presented to the winners at a celebratory lunch

## Criteria

The judges will be looking for case studies where companies have been able to demonstrate sustained performance in environmental supply chain planning and execution. This will include compliance with environmental regulations, minimizing waste from the supply chain process, reducing the carbon footprint and the overall adoption of “green” practices across the supply chain.

Companies should demonstrate they have taken measures to improve their environmental performance, such as through applying environmental criteria to assess and choose suppliers, and/or actions they have taken to control emissions from transport requirements.

Companies should adhere to all official national, regional and global environmental guidelines set for their industry.

3

Companies should be able to show how the company has benefitted financially from implementing green initiatives.

- ✓ Dates
- ✓ Brief Description of project and results
- ✓ Contact Details

# Executive Green Supply Chain Award

- 3** Please explain the steps your organization took to address these issues. How has this program evolved over time? Who are the key business partners involved, and what are their roles and responsibilities? (100 words)
- 4** Please outline the progress you have made on you supply chain's green or sustainability initiatives. What makes this an award-winning success? How will your company proceed in the future? (100 words)
- 5** What are the key lessons learned and best practices other supply chain executives can take away from your experience? (100 words)

# Terms and Conditions of Entry

1. All entries must be a truthful representation of the entrant's commitment to sustainable, green practices carried out within an ongoing program with set objectives and measurable outcomes designed to reduce the greenhouse emissions and environmental impact of their organizations or communities.
2. All entrants agree to be bound by the decisions of the judges and accept no correspondence will be entered into in relation to decisions reached.
3. All material submitted in support of an entry is warranted by the entrant to be their property and is entered without any encumbrances by third parties.
4. The entrant indemnifies and agrees to keep indemnified the organizers of the Executive Green Supply Chain Awards for any claims arising out of any material, statements or claims made as part of their entry.
5. The entrant agrees that the organizers of the awards are entitled to judge their entry and select what they consider to be the winner in a given category without recourse to the entrants.
6. The entrant agrees that should they win an award they will provide a representative to attend the award ceremony to accept the award.
7. If the entrant wins an award it grants permission to the organizers to use any photographs, video, sound, written or other material as it sees fit and without restriction.
8. Entries received without the required entry form will be deemed invalid and withdrawn from the Awards.
9. The Executive Green Supply Chain Awards reserves the right to withdraw an entry from the judging process at any time if the entry is deemed inappropriate for any reason.
10. The Executive Green Supply Chain Awards' decision is final.
11. Organizers reserve the right not to award a category at its own discretion and without recourse to the entrants of said category.
12. The Executive Green Supply Chain Awards reserve the right to nominate the entrant in other categories that the organizers feel appropriate.
13. The person named on the entry form will be the person contacted by the Executive Green Supply Chain Awards if they are successful.
14. If the name of the nominated contact person changes, the Executive Green Supply Chain Awards must be contacted immediately.
15. Shortlisted entrants may be required to provide additional information upon request from the Executive Green Supply Chain Awards.
16. The Executive Green Supply Chain Awards and all its Intellectual Property remains the sole copyright of The Professionals Network.
17. Entries will be judged by a panel of judges. Organizations can enter as many categories as they like.
18. The winners of the awards may state in advertising, promotional material and on their stationery that they are a winner, but this must make it clear which category and the year in which they won.
